### \*\*\*FIRST DAY TO SUBMIT NOMINATION PETITIONS AND PAPERS \*\*\* IS TUESDAY, MAY 10, 2022

Supervisor of Elections Caroline F. Fawkes is reminding aspirants that the first day to submit Nomination Petitions and Papers is **Tuesday, May 10, 2022, by 6:00 PM. The deadline to file is May 17, 2022, before 5:00 PM.** Offices on St. Thomas and St. Croix will remain open until **6:00 PM on May 10<sup>th</sup>**. And on St. John, the office hours will be 9:00 AM - 4:00 PM. Regular Office hours and locations are as follows:
