## VOTER REGISTRATION HOURS EXTENDED ON THURSDAY, SEPTEMBER 30TH

*IN OBSERVATION OF NATIONAL VOTER REGISTRATION DAY (NVRD)*

In observation of National Voter Registration Day, the Elections System of the Virgin Islands announces extended operational hours for **Thursday, September 30, 2021, at their St. Thomas and St. Croix offices.** The extended office hours are 8:30am - 6:00pm. The purpose is to accommodate persons that work beyond the current temporary office hours.

The Elections System of the Virgin Islands has joined the nation in celebrating National Voter Registration Day on **Tuesday, September 28, 2021.** It is a civic holiday in the United States and is celebrated the fourth Tuesday of September each year. The day seeks to create broad awareness of voter registration opportunities to reach tens of thousands of voters who may not register otherwise.

Due to COVID-19 and limitations on public activities, the Elections System has extended its celebration of National Voter Registration Day to a week, which started on September the 27th and will conclude on Friday, October 1st. Fees for replacement cards will be waived during this period and free hand sanitizers will be distributed. Office locations and time are as follows:

Documents Required for Registration are as follows: Birth Certificate **or** U.S. Passport **or** Military Discharge from (DD214) **or** Naturalization Certificate **and** provide the last four digits of your Social Security Number.
