CAMPAIGN DISCLOSURE REPORT DUE (DECEMBER 30th)

The December 30th Report Period Campaign Disclosure Report for candidates and political committees is now due. St. Croix Candidates, Senators or Governor are asked to drop off this packages at the two (2) designated sites on the island of St. Croix.

Supervisor Caroline F. Fawkes reminds candidates and political committees pursuant to Title 18, Virgin Islands Code, Section 905 that the December 30th Campaign Disclosure Report is now due. Supervisor Fawkes states that, "The December 30, 2016 Disclosure Report must be submitted to the Office of the Supervisor of Elections **no later** than **January 16, 2018.**" **Important Note:** If you have closed your account please submit your bank statement reflecting that fact and if you have **under \$500** left in your account during this reporting period, you **do not need** to submit a report.

ATTENTION (St. Croix Candidates, Senators or **Governor**): **The St. Croix District Office remains closed until further notice.** therefore two office locations have been designated where you can drop off your packages. The contact personnel and agency locations and times are indicated:
