The Elections System of the Virgin Islands has completed an audit review of the Unofficial Territorial Election Summary Results Report released on Tuesday, November 3, 2020 at 11 p.m. At this time, with the accounting of early voting and election day results only, votes cast for Senator Sarauw are now recorded as 4,248 and votes for Senator Donna Frett Gregory are now recorded as 4,223. Both candidates Sarauw and Frett-Gregory were contacted and notified of the situation.

After the reading of the St. Thomas/St. John early voting results on November 3rd, the At-Polls results were read in the specified district and the results were inadvertently combined with the STT/STJ district early voting results when submitted to the St. Croix district for final merger, as per established protocol. This combination of results caused a duplication of the STT/STJ early voting numbers. The conducting of audit reviews is typical in the election industry to ensure accuracy of UNOFFICIAL RESULTS. The audit verified that the standing of no other candidates has been affected.
